BY-LAW NUMBER 2009-04-014

A By-Law to Amend Comprehensive Zoning By-law No. 08-04-391 of the Township of Laurentian Valley.

PURSUANT TO SECTION 34 OF THE PLANNING ACT, R.S.O. 1990, c.P.13, AS AMENDED, THE TOWNSHIP OF LAURENTIAN VALLEY HEREBY ENACTS AS FOLLOWS:

1. That By-Law Number 08-04-391 is hereby amended as follows:

Schedule 'A-4' to By-law Number 08-04-391 of the Township of Laurentian Valley is amended by rezoning lands known municipally as 180 Golf Course Road, located within Part Lot 37, Concession 1, in the geographic Township of Stafford, from "Residential Three-Exception Three-holding (R3-E3-h)" to "Residential Three-Exception Three (R3-E3)" as shown on Schedule "A" attached hereto.

2. THAT save as aforesaid all other provisions of Comprehensive Zoning By-law 08-04-391, shall be complied with.
3. This by-law shall come into force and take effect on the day of final passing thereof.

READ A FIRST AND SECOND TIME THIS SEVENTH DAY OF APRIL, 2009.

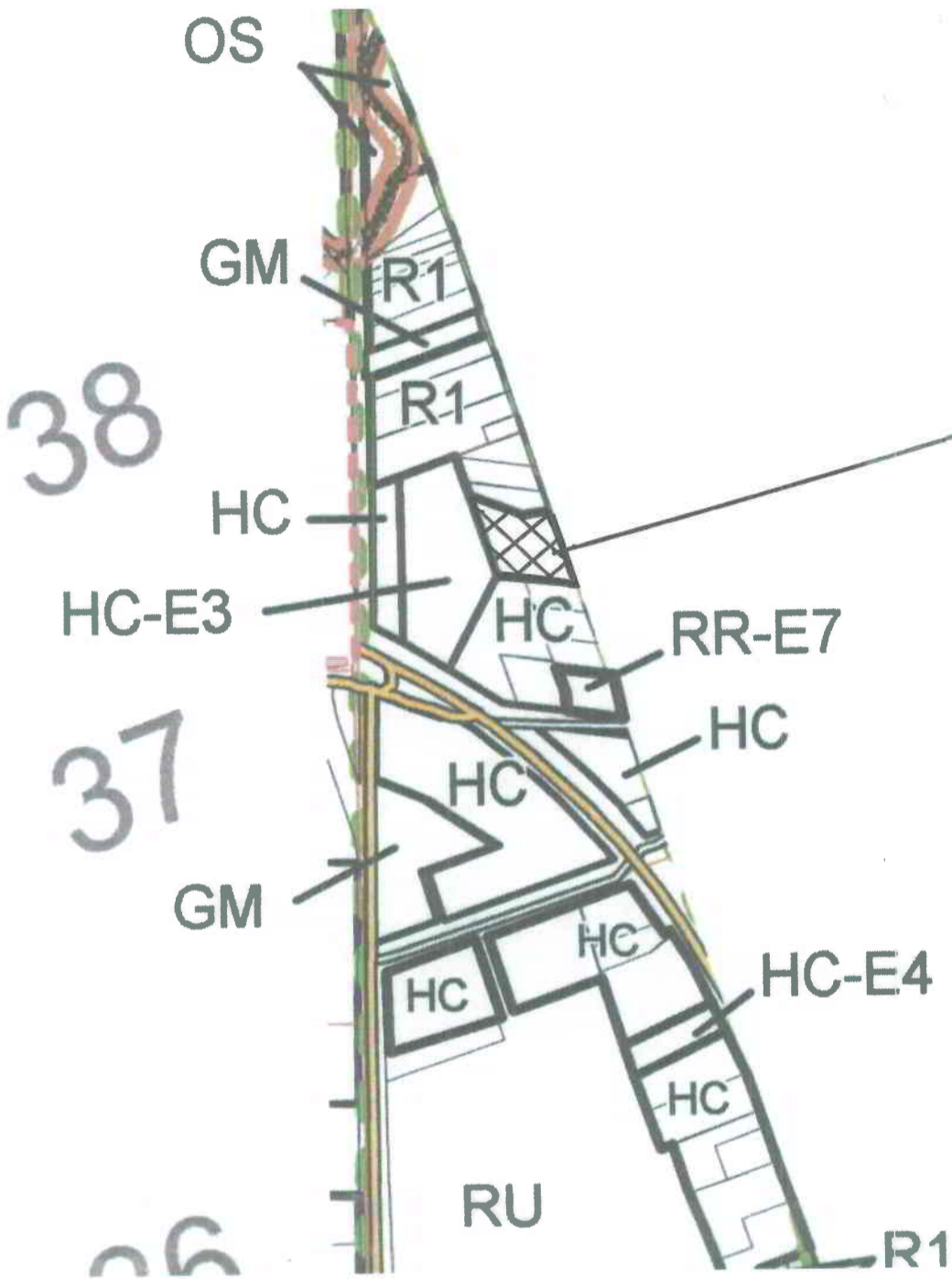
READ A THIRD TIME AND PASSED THIS SEVENTH DAY OF APRIL, 2009.

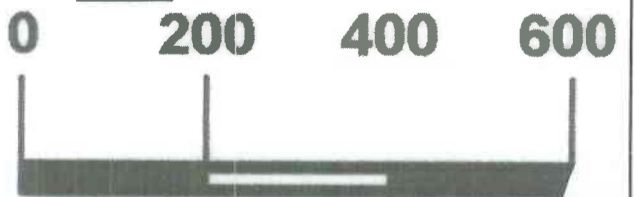
